## Financial Status Update

Mr. Sawyer gave a brief, high level financial update for each district. More detail will be given at the individual board meetings in January.

## Superintendent's Report

Dr. Levy reported that the first Supervision District Budget Workshop is scheduled for December 6th. She also updated the Boards on the following recent activities: VRHS hosted a visit from the NEASC accreditation committee; Seniors at Valley were recently trained (in accordance with state statute), and also certified in CPR; the High School Scheduling Committee held their first meeting to examine the pros and cons of the current block schedule as well as other schedule types; She recently awarded the Shoreline Superintendent Award to Valley Seniors Mitch Conrad and Maggie Walsh. She noted that both of the students attended Region 4 schools from K-12.

#### Committee Reports

The November meetings for both Joint BOE Policy and Joint BOE Curriculum were cancelled.

Joint BOE Finance Committee - Committee Chair Mark Watson reported that they met on November 29th and discussed the following: medical insurance issues, including the fact that the insurance reserve took a big hit last year due to higher than anticipated claims. They will revisit that fund balance again as we get further into the claims year to see how claims are shaping up. Depending on continued claims activity, they may need to be more conservative in proposed budgets for next year.

#### Assistant Superintendent's Report

Assistant Superintendent Martineau gave an update on Professional Development and Curriculum. She reported that they are in the process of planning a tech summit full PD day in March with teacher leaders running the workshops in their areas of tech expertise, or tech application areas they feel passionate about.
