# Principal's Update

Mr. Stickland gave an additional update of events at DRES. The PTO Craft night was a big hit. The chorus sing-a-long was well attended. We have DRES spirit wear available. Academics and Achievement have gone out and will run in connection with our Invention Convention. This will be held on March 10th which will showcase the experiments. Judging will be on March 11<sup>th</sup>. On January 12th students participated in the CAS leadership program. We have 2 students who will attend the Evening of the Arts at the end of February. CMT science testing will take place in March. SBAC will be at the end of March. Five of our students will go to the Coast Guard Academy for Math Counts. Professional Development focused on an overview of SBAC and how to integrate in their day to day instruction. Teachers will be meeting with Mr. Strickland for their mid-year meetings. The PTO is hosting a magician for Family Fun Night. There are 24 students participating in the production of Robin Hood.

#### Financial Status Report – Mr. Garth Sawyer

Mr. Sawyer gave a brief update of the financial status for Deep River Elementary School for the 2015-2016 school year. The property and liability insurance for the building has increased. Currently the school budget is projecting a deficit due to some unanticipated special education needs. We will remain vigilant of any unforeseen circumstances and we will keep the Board informed of any developments as they arise.

Mr. Sawyer gave an update on the status of the cafeteria budget. There has been an increase on the daily average of meals sold.

#### **Supervision District Committee Update**

There were 2 budget workshops which resulted in a budget that has an increase of 2.78%. Most of this increase is for a Math Coach who will work with the teachers in all four schools. This will go to a public hearing on February 1<sup>st</sup>.

Discussion occurred regarding maintenance and upkeep items which have been done on the school. Mr. Strickland noted that the roof project is complete and there have been no leaks. Drain spouts have been worked on. There was a freezer alarm placed on the freezer. Gas lines have been run to the buildings but are not hooked up. There was paving done in the main parking lot. Lighting enhancements are being looked to increase safety.

#### **Assistant Superintendent's Report**

Ms. Martineau discussed the changes in curriculum for social studies. She met with all three town's historical societies to discuss working together. We will be working with them to implement our new social studies curriculum. We will honor the history of all three towns and find what binds us together. Our Tech Summit is coming up in February. Teachers will attend various workshops. We have been working with the Language Arts coaches looking at the writing assessments for the Elementary Schools. This is based on real time assessments of what our students are doing.

# SUPERINTENDENT'S REPORT

#### **District Update – Information and Communication**

Superintendent Levy noted that we are developing our five budgets. On February 8<sup>th</sup> from 6-7pm there will be a community dinner which will be open to families. Jonathon Costa will be giving a presentation. This will allow the public to be thinking of how our communities want to move forward. Celebrate Learning will once again be held at Deep River. There has been a push from the federal government to provide breakfast and lunch for our students in need. We would have reimbursement for all children in our district. Students would pick up a brown bag and they have to eat on school grounds. More information will become available soon.

We have been working on the budget process. We have completed the first phase of the Supervision District budget. It will go to public hearing. The increases are due to mandates.
