High Level Financial Status Updates for all Boards

Presentation and VOTE to approve the 2017-18 Supervision District Budget as presented

Dr. Levy discussed what was included in the Supervision District budget. She is confident that we are able to meet the needs of our students with this budget. The finalized budget has a decrease of -0.47%. This will become the foundation for the elementary budgets. Ms. Grow questions whether there is a need this year for a dyslexia specialist. This would allow us time to review our needs. Dr. Levy stated that currently we use outside services for this expense and it is more costly. She asked members to contact their legislators regarding the cost to the towns for the unfunded mandates.
